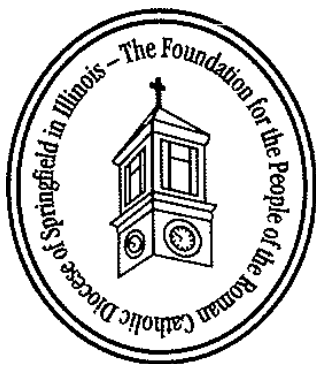

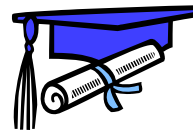

Sr. Maristella Scholarship Fund

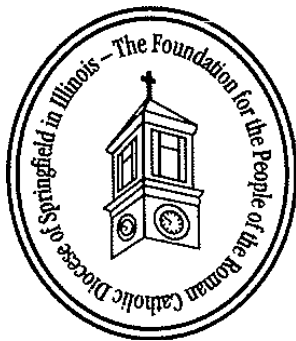
